## CURRICULUM AND INSTRUCTION

### Standards Based Report Card

On a motion by Trustee Macias seconded by Trustee Baird and unanimously carried, the Board approved piloting the Standards Based Report Card at Loma Vista School and McKibben School as recommended by the Curriculum Council. Gail Baxter, Assistant Superintendent of Educational Services, presented a thorough report on the introduction of the standards based report card. There was wide involvement and input by the Curriculum Council, teachers and District Advisory Committees on the standards based report card. Parents told Mrs. Baxter they were glad to see an updated report card being considered. Training will be provided for teachers, school secretaries and parents on understanding this new reporting system. Loma Vista and McKibben were chosen as the pilot schools because they have a full range of grades from Kindergarten through 6<sup>th</sup> grade and because one is a PI school and the other is not. McKibben School Principal, Mr. Alarcon, has experience with this type of reporting system and will assist the district in implementing the report card at the pilot schools.

#### **BUSINESS**

Budgetary Assumptions for the 2011-2012 School Year David Rivera, Assistant Superintendent of Business Services, presented Budgetary Assumptions for the 2011-2012 School Year report to comply with DAIT recommendations. This report precedes the proposed 2011-2012 Budget that districts must file with the county office no later than June 30, 2011 and provided preliminary budget data. The Budget that will be submitted for approval at the June 28, 2011 Board meeting includes a multi-year projection that covers the current year and the subsequent two fiscal years.
