Trustees Baird and Macias both attended the Graves Middle School Band Concert and agreed it had been an impressive event. Music teacher, Mr. Shiffermiller and the students were commended for their performance. Trustees also said Mr. Shiffermiller is a gifted music teacher. Trustee Baird took the opportunity to join sixth grade Lake Marie, McKibben and Loma Vista students at Sixth Grade Camp in Malibu. This proposed school district contribution would begin in the 2014-2015 school year with a 1½ % increase eventually increasing to 19%. Districts are anticipating more information.

Dr. Kwek thanked everyone involved in organizing the retirement dinner held for him. He felt humbled for the kind recognition and said all committee members had done a fantastic job in planning this event.

Local Control Accountability Plan Update

Gail Baxter, Associate Superintendent of Educational Services, presented an update of the Local Control Accountability Plan. Mrs. Baxter expanded information on the 'draft' copy of the Local Control Accountability Plan (LCAP) that had been given to the Board at a previous meeting. Since that time, Mrs. Baxter has rewritten the LCAP, she made revisions and additional revisions were made, with the latest revision an hour before the start of the Board meeting. Although revisions have been made, Mrs. Baxter reported that priorities set by the community will still be incorporated into the plan. In the revised LCAP, the plan format will read as it did in the first draft but there will be more data as opposed to a narrative format. Some items listed in the draft plan for year one implementation will have to be moved to year two due to affordability. Items are still a priority as listed but will have to be delayed. Mrs. Baxter is consulting with the Business Office as the LCAP budget and the district's budget have to be in agreement.
